"Marketing Your Nuclear Medicine Department" will attract an SRO crowd and is sure to be of interest to everyone. Discussions will cover the use of marketing techniques to encourage referring physicians to use the nuclear medicine department as well as increasing outpatient volume and repeat patient activity.

On Monday morning, a session on pediatric nuclear medicine will cover the trend of increasing accessibility to nuclear medicine for use in pediatrics on the community hospital level. Monday's agenda will also offer an opportunity to find out, in-depth, about alternatives to standard techniques unique to nuclear technology and oncology.

A three-hour session on radiopharmaceuticals is scheduled for Monday afternoon. This session will discuss the use of a variety of agents for labeling white blood cells. There will be another three-hour session Monday afternoon on clinical imaging.
