mains active in the Section and in the SNM Central Chapter, Technologist Section, which he represents on the National Council. Jim previously served on the NMTCB Board of Directors from 1988-1991. Jim brings to the NMTCB educational, clinical, and professional experience that will enhance his contributions as a board member.

Summary of the June 1992 NMTCB Exam

The NMTCB examination was administered on June 27 to 414 candidates.

The examination, which was based on

the April 1988 Task Analysis, consisted of 200 scored items and 50 pretest items that were not used to compute the examinees' scores. Each examinee answered a total of 225 test items.

Summary of the September 1992 NMTCB Exam

The NMTCB examination was administered on September 26 to 627 candidates. The examination contained 200 items that were used to compute the examinees' scores and a total of 75 pretest items that were not used to compute the scores. Each examinee answered a total of 225 test items. The examination was based on the 1988 Task Analysis and was slightly harder than the June 1992 exam.

Scores on the September 1992 examination were equated to be comparable to the standard set for the June 1992 examination. The passing score on the September 1992 examination was set at 119 items correct. Of the 627 examinees tested, 498 (79.4%) met or exceeded the passing score; 129 examinees (20.6%) failed the examination.

In summary, the NMTCB examinations administered in June and September 1992 were technically sound and performed comparably to the NMTCB examinations administered in the past several years.

There was a significant increase in the total number of examinees in 1992. In 1991 a total of 863 examinees sat for the NMTCB; in 1992 1041 examinees took the NMTCB.
