Persons desiring to present third-party oral testimony at a board meeting must submit a written request to do so. Third-party testimony, written and oral, must be limited to compliance of the educational program with the Accreditation Standards for Nuclear Medicine Technologist Education. Such testimony must be received at the JRCNMT office no later than April 1, 2017.
