#### Southeastern Chapter

Nine of the scientific papers presented at the Annual Meeting were by technologists. These were judged and plaques and cash awards were presented to the top three. First place went to Lynn Bass, University of Tennessee, for "Comparison of Bone-Soft Tissue Using Tc-99m EHDP and Tc-99m HMDP." J.D. Billingsley, University of Alabama, won second place with "Nuclear Medicine's Role in Accidents Involving Radioactive Materials." The third place award went to Helen Bunch, VA Medical Center, Birmingham, Alabama, for "Criteria for Evaluation of RIA Kits."

Plans are being made by most of the states for annual spring meetings. "Scintigraphy of the Chest," with sessions on lung and heart, will be the topic of the Alabama meeting to be held April 9-11 at the Alabama Conference Center in Birmingham.

Florida's annual meeting and registry review will be April 30-May 3 at the Airport Holiday Inn in Tampa. The Florida technologists are addressing the problem of decreasing numbers of applicants for nuclear medicine educational programs and attempting to develop means of promoting nuclear medicine as a career.

Historical Shakertown will be the site of the Kentucky Annual Spring Meeting April 25. A special report will be given at the meeting regarding the status of licensure.

Officers were elected at the September meeting of the Ohio Valley Nuclear Medicine Technologists. There was a review of techniques and procedures of pediatric nuclear medicine at the November meeting.

The three sections in Tennessee—East, Middle, and West—continue to meet individually on a regular basis. The three sections will meet together in Memphis May 1–3 at the Hyatt Regency for the Annual State Meeting. A chartered bus, the "Tech Express," will originate in East Tennessee and travel across the state, picking up technologists for the Memphis destination.

The Society of Nuclear Medicine of Puerto Rico, which is celebrating its tenth anniversary, has devised a very interesting program for this year.
